Sieć #helllo5G Orange available in Tri-City

Orange Polska has informed of extending its 5G network coverage to include the Tri-City area. The newly launched network can be used by 90 thousand people living in Gdansk, Gdynia and Sopot.

At present around 6 million people in 400 places around Poland can use the services of the 5G network of Orange Polska.

Polish 5G: Prices of terminals are going down but Internet access is getting more expensive

In 2021 we may expect the decisions in the 3.6 GHz spectrum auction, fast development of 5G network coverage and changes among the network infrastructure and smartphone suppliers.

At the beginning of the year Polkomtel (a Cyfrowy Polsat Group company) offered the biggest 5G network coverage in the country –the 5G services of Plus network were available to over 7 million people

At the same time, the number of affordable 5G smartphones has been growing. According to a list developed by *"Rzeczpospolita"* daily, the average price of a 5G terminal decreased from ca. PLN 4 thousand down to ca. PLN 3.5 thousand during the fourth quarter of 2020, while the cheapest models cost less than a thousand zloty. Handset manufacturers' representatives say that 5G handsets will make a substantial part of their new product offers this year.

A reverse trend, compared to what is happening in the smartphones area, is visible in the case of mobile 5G Internet access. Plus, who in May 2020 offered access to 5G services to all of its users using 5G terminals within the 5G network's coverage footprint, has now divided its subscriptions into two types, namely the ones without 5G and the ones with 5G access. The prices of 5G subscriptions start from PLN 60 monthly (including all discounts), which means that access to the new technology costs two times more as compared to earlier offers (PLN 30). Even though Plus's 5G has become more expensive, it is still cheaper than Orange who from the launch of its 5G network offered access to 5G only to the users of higher end subscriptions (costing minimum PLN 75 monthly).

Rp.pl#Polskie5G and the auction at one go?21 January 2021by Urszula Zielińska

Polish government has presented yet another draft amendment of the law on the national cyber-security system (KSC). The draft has been developed following the consultations with market players in Poland.

KSC is a legal act whose adoption is indispensable to start the first process of spectrum allocation for 5G networks (the band C spectrum).

The new draft law extends, by two years compared to the previous version, the period during which the operators will be required to abandon use of the infrastructure provided by the so-called high risk suppliers.

Moreover the draft gives the President of the Office of Electronic Communications the right to allocate spectrum to a wholesale operator who would then be granting access to its network on non-discriminatory basis (the #Polish5G project).

A state-owned mobile network and a state-owned operator will be established

The new version of the amended law on the national cyber-security system (KSC) includes a proposal of establishing a new telecommunication operator who will be providing services for the central government authorities.

The operator of such a strategic communications network, being a sole-shareholder company owned by the State Treasury, will have the task of providing the services for the needs of the President's Office, the Prime Minister's Office, the lower house of the Parliament (Sejm), the Senate, the National Security Office, the army, the military police, etc. Such an operator will be able to request that paid access to the infrastructure be provided by an existing telecommunication company. Where a relevant agreement proves impossible to conclude, it will be replaced by a decision issued by the President of the Office of Electronic Communication.

Telko.inNetia will be powering its data centers while relying on green energy22 January 2021by Marek Jaślan

Netia (a Cyfrowy Polsat Group company) has entered into an agreement with Innogy Polska which guarantees supply of green energy via selected lines supplying its data centers in Warsaw and Cracow with electricity.

Thanks to the agreement, starting from 1 February 2020 Netia's key data center facilities, as well as NetiaNext cloud services, will be powered by green energy supplied from land-based wind farms. In the case of the data center currently constructed near Warsaw, it is also the emergency power supply that will be ecological.
