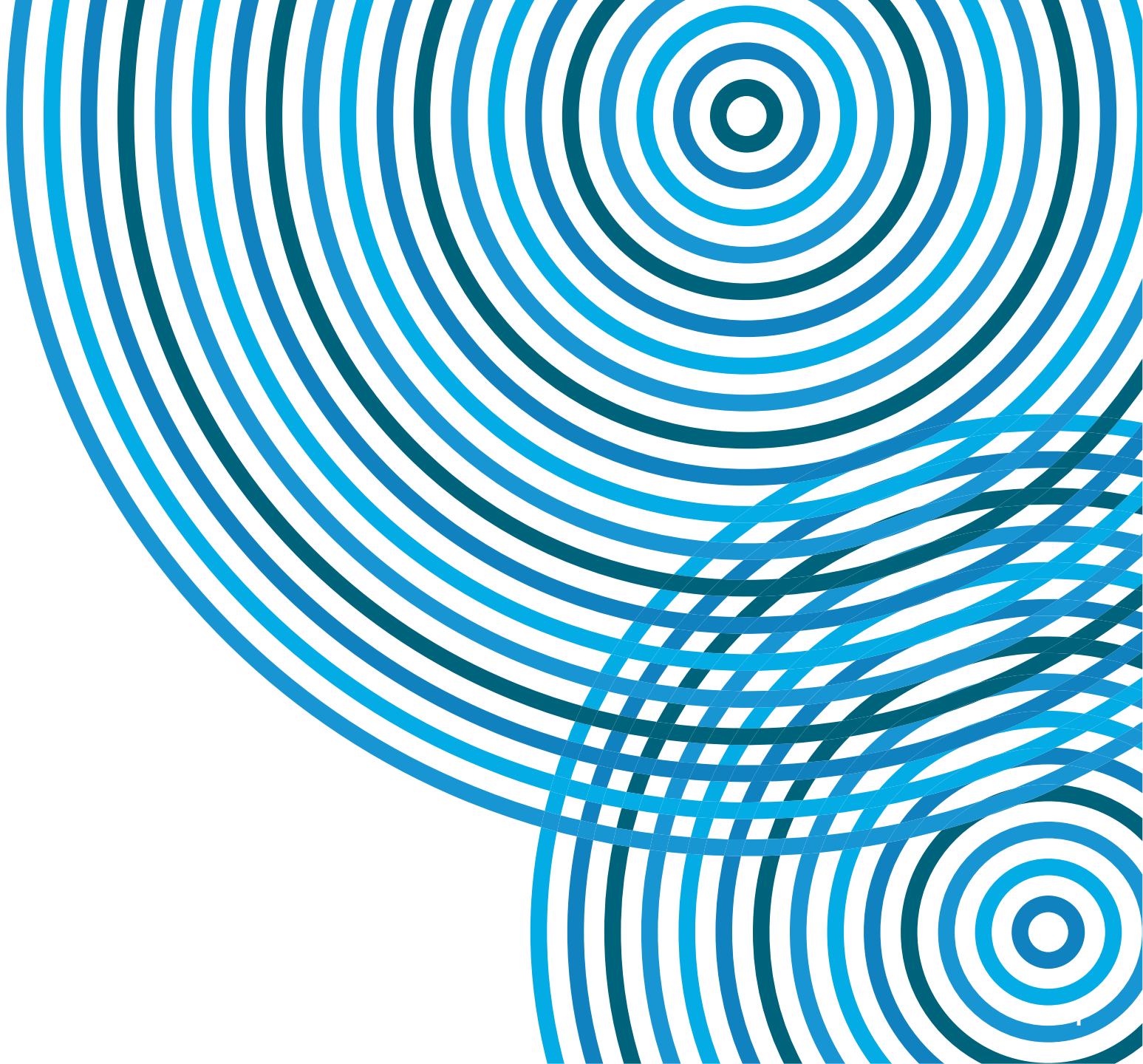

## **UKE launched a second consultation proceeding regarding the 3.6 GHz band auction**

On April 6, 2023 the Office of Electronic Communications (UKE) launched the second consultation procedure for frequency reservations in the 3.6 GHz band. UKE plans to distribute four reservations in the auction, with a starting price of PLN 450 million.

The deadline for submitting consultation positions is May 12, 2023.

According to UKE's earlier announcements, the frequencies should be handed over to operators in August 2023.

## UKE announces second consultation for auction of 4 frequency reservations in the 3.6 GHz band

UKE has announced a second consultation procedure for the auction of four frequency reservations in the 3.6 GHz band dedicated to 5G.

The starting price of a single reservation remained unchanged (PLN 450 million), while the range of each offered frequency block increased from 80 MHz to 100 MHz, spread between 3400 MHz and 3800 MHz.

In addition, due to the geopolitical situation hindering international cooperation, UKE has identified a list of municipalities in the border belt in the north and east of Poland (about 5% of the country's area) that are not covered by the territorial obligation of 5G network coverage. Moreover, the national road network coverage obligation was extended from 60 to 85 months.

Contrary to operators' earlier requests, the methodology for testing the implementation of investment commitments will remain defined outside the auction documentation. The quantifiable requirement to install 3,800 5G transmitters within a certain period of time, in certain types of areas, also remains in the commitments.
