Orange Polska wants to present the plans related to its towers in February 2022

At the beginning of next year, probably while presenting the results for 2021, Orange Polska intends to present the results of its analyses related to its towers.

The **CEO of Orange Polska, Julien Ducarroz**, does not rule out cooperation with Cellnex in the course of 5G network infrastructure roll-out.

At the same time he stressed that the operator did not contemplate any changes in the cooperation with T-Mobile, carried out via NetWorks!, thanks to which the two operators share their network resources (base stations).

More than 300 thousand mobile numbers ported between networks in Poland during three months

Office of Electronic Communications informed that nearly 333 thousand mobile numbers (MSISDNs) were ported between mobile networks in Q3 2021.

The best net MNP result was posted by UPC Polska (who is to be taken over by Play), i.e. a positive MNP balance of +7,4 thousand. The second spot went to Premium Mobile (a Polsat Plus Group company): +6,2 thousand. Vectra and Multimedia were third and fourth with +3.2 thousand and +1 thousand mobile numbers respectively.

Out of the four biggest mobile operators it was T-Mobile who posted a positive MNP balance of +0.4 thousand, while the remaining players showed negative balances: Orange: -4.2 thousand, Polkomtel (Polsat Plus Group): -7.7 thousand, Play: -21.1 thousand.

Plus's 5G network in Piotrków Trybunalski achieves data speed of 1 Gbps

Ericsson informed that a record data transfer rate of 1 Gbps was achieved in the 5G network operated by Plus (a Polsat Plus Group company) in Piotrków Trybunalski.

The above result was achieved thanks to 5G carrier aggregation (2600 MHz TDD) with the LTE carriers (from the 1800 MHz and 2100 MHz frequency bands) while using the Ericsson Radio System solutions.

Thanks to the successful implementation of the carrier aggregation solutions, the users of Plus's 5G network in Piotrków Trybunalski can enjoy the fastest data speeds which can substantially exceed 600 Mbps when downloading data.

Polish Internet survey, 6 October 2021

Results of the Mediapanel survey for September 2021

According to an Internet survey (Mediapanel), Polsat-Interia Group recorded substantial growth of the number of users in September 2021 (from 19.96 million to 20.26 million).

In addition, as regards data usage on mobile devices, which account for the majority of the traffic in the Internet, in September Polsat-Interia Group surpassed, for the first time in history, one of the two biggest Internet publishers in Poland.
