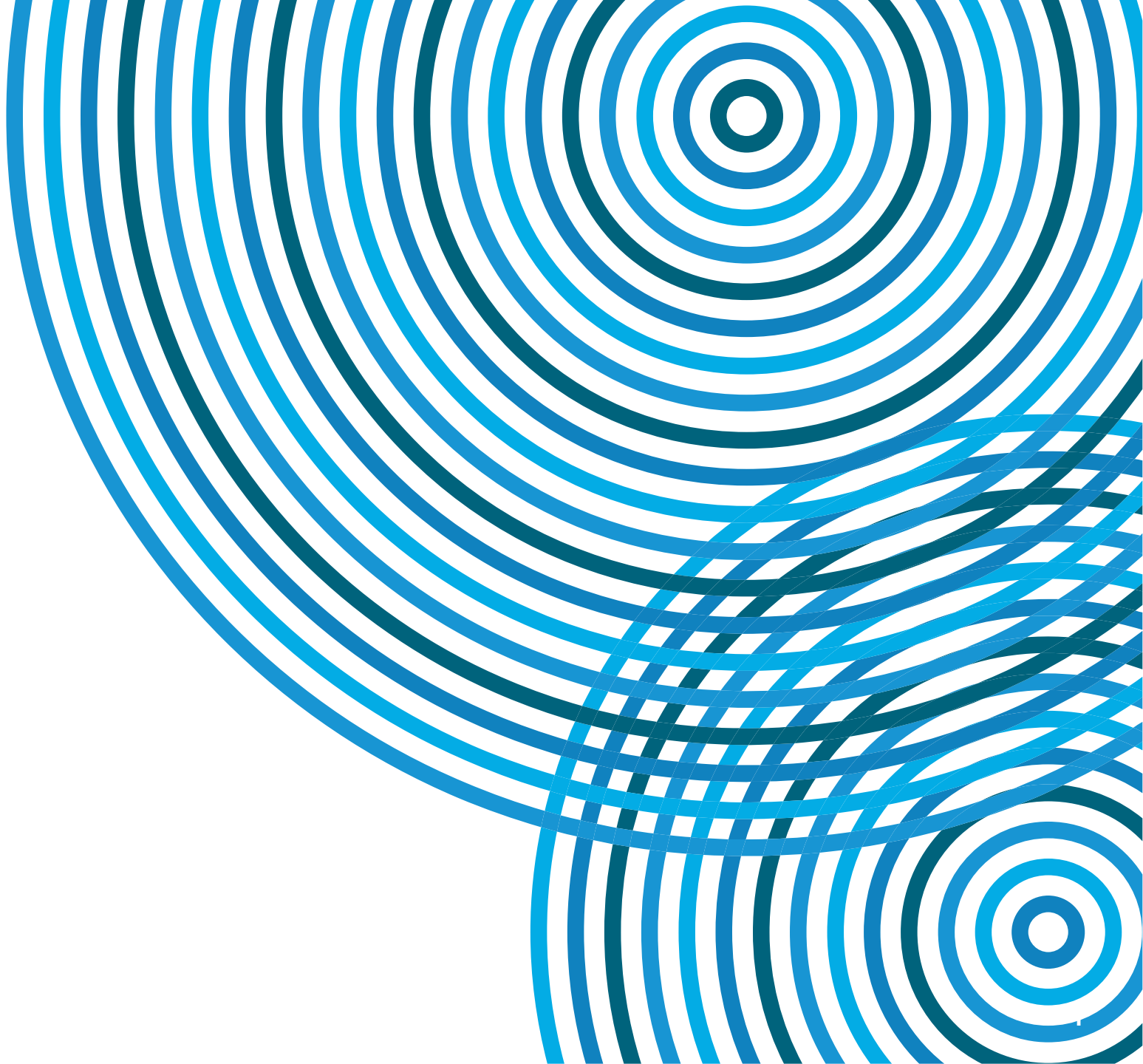

Orange Polska to increase prices? The operator adds new clauses to contracts

Orange Polska recently announced that it is introducing inflation clauses in contracts with individual and SOHO customers, in accordance with which it will be able to increase prices of services during the course of the contract, starting next year if the average annual inflation rate is above 3.5%.

As the operator stresses, the price changes will not be automatic and in the event that the indexation clause is triggered, customers will be informed 30 days in advance and will have the right to withdraw from the contract without cost.

T-Mobile Poland has been using similar clauses in new contracts with customers since July this year, citing the current economic situation and rising operating costs, which may pose a challenge in the long term to maintain the highest quality of services and the pace of investments.

Cable operator Inea also plans to introduce similar provisions in new and annexed contracts (but not in existing contracts) starting in September this year.

In a Twitter post, the Office of Electronic Communications announced an investigation into these actions. According to the regulator, clauses announcing possible price adjustments are allowed in contracts, but "they must be clear, accurate and allow the consumer to discern how the price will change already at the time of contract conclusion." In addition, the regulator stressed that the index of valorization must be objective, and that no valorization clauses can be introduced in existing contracts unless the contract provides for it. If it does not provide for it, such a change in the contract (price) results in the possibility of its termination without payment of contractual penalties.
