

European Commission: approval for InfraVia and P4 to acquire joint control of FiberForce

The European Commission has consented to a fund from InfraVia Capital Partners group taking a 50% stake in FiberForce, owned by P4, the Play network operator.

Last June, it was announced that P4 would transfer its wholesale broadband network (HFC and FTTH lines built in the past by UPC Polska) to FiberForce. There are about 3.7 million households within the reach of this infrastructure, and the agreement between the partners envisages expanding coverage by another 2 million households.

The purchase price for the 50% stake in FiberForce by InfraVia is PLN 1.775 billion.

Ursula von der Leyen: Gas from Russia is a thing of the past. The EU will build a hydrogen powerhouse

In a speech at the European Parliament during the State of the Union Debate, **European Commission President Ursula von der Leyen** outlined, among others, one of the goals of actions, which is to reorganize the energy market through the development of the hydrogen energy sector.

The European Union will invest 3 billion euro in the establishment of a new European hydrogen bank, which is a fuel on which, beside renewable energy sources (RES), the EU's energy future is to be based.

T-Mobile begins 3G network shutdown

T- Mobile has begun the process of phasing out its 3G network, which will last until the end of 2023.

This is one of the stages of the operator's preparation for the ever-increasing demand for data transmission. The recovered frequency resources will be allocated for newer generation networks (4G, 5G).

Canal+ tightens cooperation with Polsat. "The era of exclusive channels is coming to an end"

Subscribers to Canal+ online service have gained access to Polsat and TV4 channels. Earlier, i.e. in December 2021, Polsat Box platform added Canal+'s thematic stations to its offer, and in 2018-2019 the two platforms agreed to cooperate on making selected sports channels available to each other.

As **Marek Sowa, media market expert**, assessed in an interview with Wirtualnemedia.pl, the extremely expensive sports broadcasting rights, but also rights to attractive film and series positions, will increasingly force cooperation between competing media groups in the area of distribution and programming.
