

Netia to provide consultants for Polregio's videomats

Netia (Polsat Plus Group) and Avista have launched a pilot project to sell tickets of the rail carrier Polregio in videomats.

The project aims to make it easier for travelers to purchase tickets and increase the availability of ticket offices.

Passengers will be able to purchase a ticket independently as in a classic ticket machine, or connect during a video call with Netia's call center, where a consultant will be able to assist the passenger in operating the machine or take over the desktop remotely and operate it on behalf of the customer.

Orange Polska saves electricity: photovoltaics on rooftops, heating up to 20 degrees in winter

The operator announced that in winter the maximum heating temperature of the office premises will be set at 20 degrees, and in summer the minimum air conditioning temperature will be 23 degrees.

New Polsat Box Go package for PLN 15 per month

Streaming service Polsat Box Go (Polsat Plus Group) has extended until the end of 2022 the period during which Ukrainian refugees can enjoy free channels in Ukrainian. Starting January 1, 2023, the Polsat Box Go Ukraine package, which includes nine popular stations, will be available for PLN 15 per 30 days.

The Ukrainian-language channels can be used by users of the Polsat Box Go service (via an application available on Smart TVs, computers and mobile devices) and Polsat Box IPTV.
