

Vectra needs more time to sell its cable network

Vectra filed with the Office for Competition and Consumer Protection (UOKiK) for extension of the deadline for fulfillment of the condition precedent for obtaining the Office's consent to acquisition of Multimedia Polska cable network by Vectra.

The consent to the concentration of the two companies was given back in January 2020, subject to Vectra off-loading its local cable networks in eight cities in which Vectra would be having excessively big market share upon the merger of the two operators.

So far a notification was made about finalization of sale of one network in Gorzów Wielkopolski.

S&P downgrades Cyfrowy Polsat's outlook to "negative" while maintaining the rating as "BB+"

S&P Global Ratings agency revised the outlook for Cyfrowy Polsat group from "positive" to "negative" while at the same time maintaining the corporate rating at "BB+" level.

In the agency's opinion, following the investments into a new sector - green energy and hydrogen - the adjusted debt to EBITDA ratio for Cyfrowy Polsat will deteriorate, exceeding 3.0x, while the free cash flow to debt ratio will drop to below 10 percent.

At the same time, the agency is of the opinion that the dynamically operating telecommunications and media segments of Cyfrowy Polsat, which rely on a convergent offer, vertical integration of media production as well as the strategic infrastructure and assets, will continue supporting the Group's operations.

Closer to the 5G spectrum auction, the draft National Cybersecurity Act reviewed positively

The Government's Committee for National Cybersecurity and Defense issued a positive review for the amended Act on the National Cybersecurity System (KSC).

In the next step the amended act will be discussed by the Government's Standing Committee. The final decision regarding submittal of the draft for approval to the Parliament (Sejm) will be made by the Council of Ministers.

At this stage, the approved draft calls for establishing Polskie 5G (Polish 5G) company by the operator of the strategic security network.

Adoption of the National Cybersecurity Act is the requirement for commencing the auction for the spectrum from the 3.6 GHz frequency band which is intended to be used for the needs of 5G network development.
