

Electronic communications law returns without extended surveillance and lex pilot

The Ministry of Digitization expects that in the second quarter of this year the government will adopt draft laws implementing the EU regulations on the European Electronic Communications Code (EELC) into Polish law.

The drafts being prepared by the Ministry of Digitization do not include previously considered solutions regarding a new obligation for electronic communications operators to store information on calls made by their customers for a period of 12 months and to make it available to the authorities upon request, as well as provisions favoring the public broadcaster in determining the order of channels in the offers of cable and satellite television operators.

The Code is a key regulation of the telecommunications market that will replace the current Telecommunications Law.

Digital Services Act will come into force in Poland after February 17, recipients include intermediary service providers

The Digital Services Act (DSA), an EU regulation governing online service providers, will enter into force in Poland after February 17, 2024.

As **law firm Chałas and Partners** points out in a press release, "in practice, all providers of Internet access, VPN, hosting, server and cloud services, as well as services that allow searching for information on the Internet, will be covered by the regulation."

The most restrictive obligations under the DSA will apply to large Internet platforms and major search engines (serving more than 45 million active users).

The DSA provides for the need to establish a new body - a digital coordinator. In Poland, this function is to be performed by the President of the Office for Electronic Communications (UKE), with some of the duties under the DSA to be performed by the President of UOKIK.

What subscription from the telco in 2024

Orange Polska does not expect the use of inflation clauses in 2024, which allow, under conditions of increased inflation, the increase of price of services during the term of a customer's contract.

"Inflation clauses have been included in our customers' contracts since May 23, 2022. As the past year has shown, we are very reluctant to use them. The introduction of clauses in 2024 is not on our agenda at the moment," Wojciech Jabczynski, spokesman for Orange Polska, told Parkiet.

The **press office of T-Mobile Polska**, on the other hand, told Parkiet that the operator has not made such a decision, but nevertheless believes that "when the level of inflation exceeds the inflation target set by the National Bank of Poland several times, operators should be able to change their charges based on an objective, independent indicator, i.e. the level of inflation published by the Central Statistical Office".
