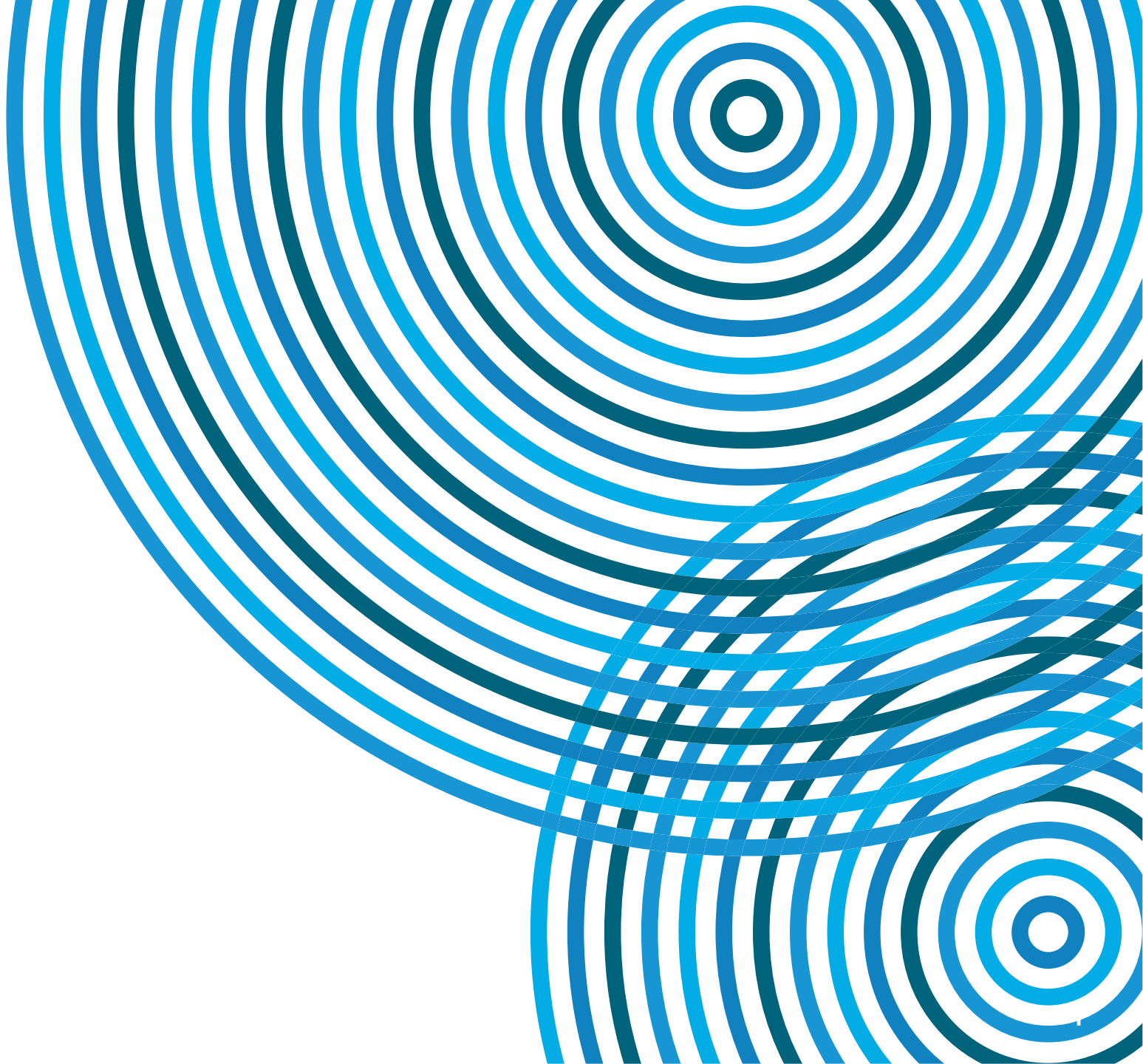

## Netia will provide MPLS services as part of the 'Pomeranian eHealth' project

The Pomeranian Voivodeship has announced a tender for the purchase of MPLS (Multiprotocol Label Switching) telecommunications and internet services as part of the 'Pomeranian e-Health' project. Netia's offer was selected for PLN 912,000 gross. The other participants in the tender are T-Mobile Polska, Gdansk University of Technology IT Centre of the Tricity Academic Computer Network and Actus-Info from Wroclaw.

## 2571 base stations supporting 5G

T-Mobile's network launched 31 new 5G base stations in C-band this week, improving fifth-generation coverage in cities such as Leszno, Poznań and Toruń. Currently, there are already 2,571 5G-capable base stations on the T-Mobile network, allowing coverage of around a quarter of Poland's population.

## Parliament adopted an amendment to the Act on Copyright and Related Rights

Parliament adopted an amendment to the Act on Copyright and Related Rights, which implements two EP directives into Polish law. First of all, it increased from 3 per cent to 25 per cent of the volume of a work that can be used to illustrate content for teaching or scientific purposes. The law also extends the rights of creators of elaborations such as literary, journalistic or musical works. Amendments favorable to the media were not supported, but the Act is intended to protect the interests of Polish creators and performers.

The Committee on Culture and Media introduced additional amendments, e.g. regarding remuneration for re-broadcasting works and setting a cut-off date for the exploitation of works that are not commercially available.

## **Polsat Plus Group and ZE PAK jointly invest in Poland's largest planned wind farm project with total connected capacity of about 500 MW**

Polsat Plus Group and ZE PAK have made a joint investment in acquiring all the shares in the companies implementing a wind power complex project with a total connected power of approximately 500 MW. This is the largest planned onshore wind farm complex in Poland. ZE PAK will acquire 99% of the shares and Polsat Plus Group 1%, with the possibility of increasing its stake in the project. In addition, agreements will be concluded to develop the project to the construction stage by the end of 2030.

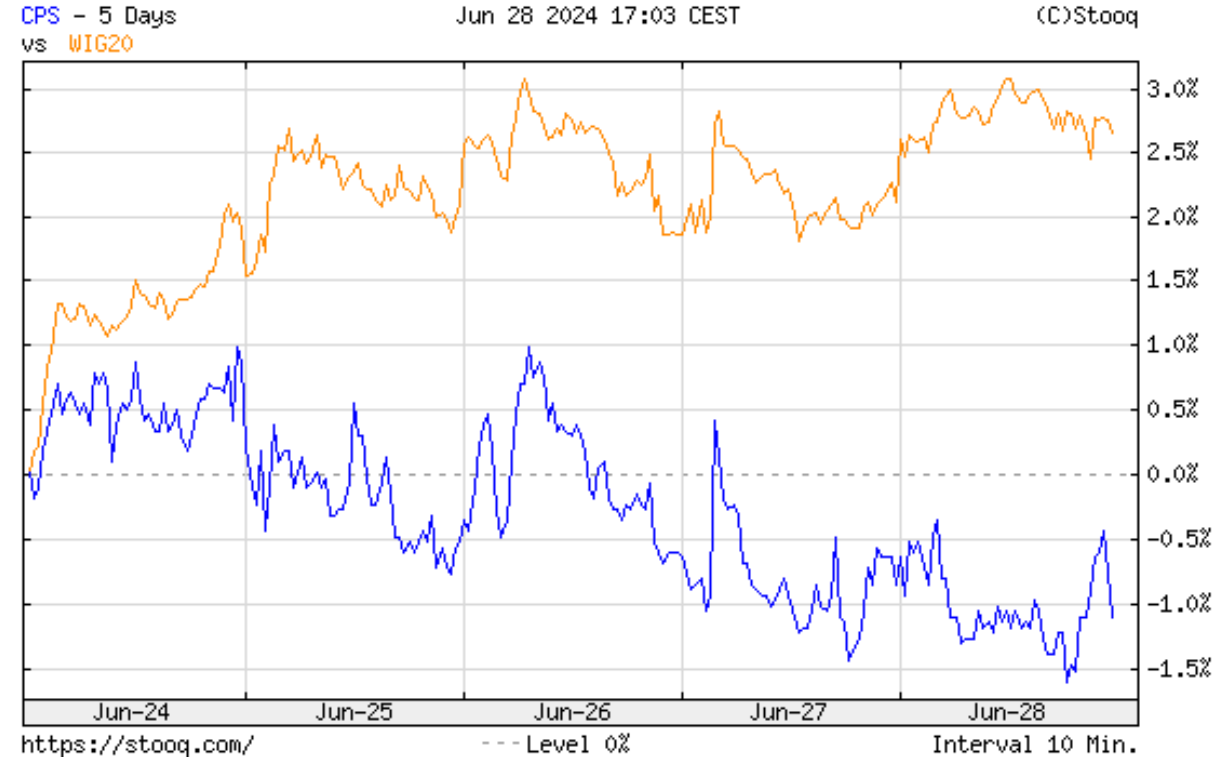
PAK-Polska Czysta Energia sp. z o.o., a member of Polsat Plus Group, and ZE PAK S.A. have made a joint investment by acquiring shares in project companies of Goalscreen Holdings Limited: Energia Przykona sp. z o.o. and Neo Energia Przykona X sp. z o.o.. These companies are implementing a project for a cluster of wind power plants in the Opole province with a total connected generation capacity of approximately 500 MW.
