

### Plus tempts students with fibre optics for PLN 19 per month


Plus has announced a promotion for students for the new academic year, offering optical fibre for PLN 19 per month with a short 12-month contract. The condition is to use other services of the operator.

Prices for users with a Plus voice subscription or Polsat Box TV are:

- 19 zł/month for 300 Mb/s,PLN
- 29/month for 600 Mb/s, ٠
- 39 PLN/month for 1 Gb/s, ٠
- 69 PLN/month for 2 Gb/s.

The WiFi router is free for the duration of the contract. Additionally, students can buy a streaming package (Disney+, Max, Polsat Box Go Plus) from PLN 25/month.

### Second 5G auction will include two types of spectrum?

The second 5G auction planned by the Office of Electronic Communications (UKE) may include two types of frequencies: 700 MHz and 800 MHz. UKE is considering combining the distribution of these bands in a single auction, which could reduce competitive pressure and the cost of obtaining the band. Paweł Puchalski of Santander Biuro Maklerskie estimates that the 700 MHz band could bring around PLN 2 billion to the State Treasury.

UKE plans to allocate 60 MHz of the 700 MHz band to telecoms operators, part of which is to be used by a special communications system for state services.

10 MHz of the 800 MHz band will also be available in the 5G auction. President of UKE Dr Jacek Oko is awaiting a decision from the Comittee of Cybersecurity on the terms of the auction. The auction of the 700 MHz band also raises the issue of interference by digital terrestrial TV transmitters from Ukraine and Russia.

### **Over 2.8 billion from KPO to support digital transformation**

Bank Gospodarstwa Krajowego (BGK) will implement a programme of loans for digital transformation of businesses, funded by the National Recovery Plan (NERP). Budgeted at €650 million, the loans will support investments in cloud technologies, artificial intelligence, the internet of things and big data. The aim is to increase the innovation and efficiency of Polish companies, especially those ready for a deep operational transformation. Deputy Prime Minister Krzysztof Gawkowski emphasises that digitalisation is the key to economic growth. A McKinsey & Company report indicates that full digitalisation could increase Poland's GDP by €64 billion by 2025.


