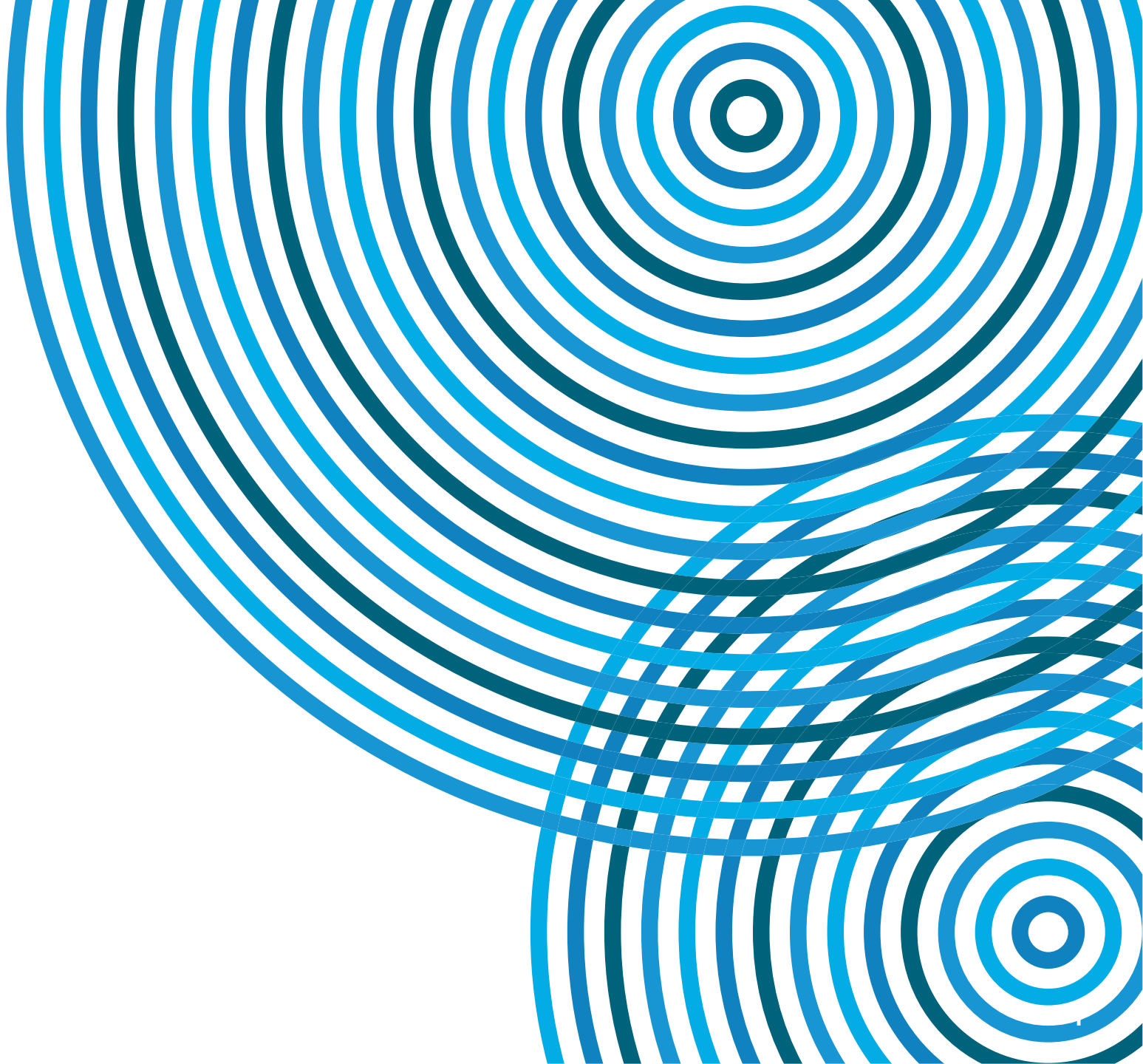

Disney+ is ending its partnership with French Canal+. What about Polsat Box?

From 1 January 2025, Disney+ and Disney's linear channels will no longer be available on French Canal+. This decision does not affect Disney's distribution agreements in other countries. In Poland, the partnership with Disney will continue and Disney channels will remain on offer from Polsat Box, Polsat Box Go, Plus and Netia. Olga Zomer, a spokeswoman for Cyfrowy Polsat, confirmed that the contract for the distribution of Disney's linear channels has been extended. Canal+ Poland also has no plans to remove Disney channels from its offer.

CPPC presented options for the recruitment of the 4th KPO competition

The Centre for Projects in Digital Poland (CPPC) presented variants of the recruitment rules for the 4th KPO competition for network construction. A workshop with representatives of the CPPC, the Ministry of Digitalisation, the Ministry of Funds and Regional Policy and telecommunications operators discussed the new rules. The call is expected to start in Q1 2025 and will last one month. Changes include no competition areas, simplified technical requirements and an evaluation system. Options for the call include de minimis and state aid. The CPPC is waiting for comments until 19 November 2024 and a follow-up workshop will be held in mid-December.

UKE puts frequencies in order. When will the mess in the ether end?

In April 2023, the UKE initiated proceedings to change the frequency reservations in the 900 MHz band used by T-Mobile Polska and Polkomtel (Plus). The aim is to ensure that each operator has access to a continuous range of frequencies to improve the efficiency of their use. The process is now nearing completion and operators should start reconfiguring their stations in the first half of next year. In the 1800 MHz band, UKE is at the stage of preliminary discussions with operators, and clean-up activities will begin once work on the 900 MHz band has been completed. In addition, in the 800 MHz band, an auction for a free block of frequencies is planned.
