

#### Warner Bros Discovery will not sell TVN

Warner Bros Discovery has announced that it is abandoning plans to sell TVN and intends to develop the station within its own structures. TVN is on the list of protected entities, which means that its sale requires the approval of the Polish government.

#### Netia adds fttr kit to 1 gb/s and 2 gb/s fiber optic in homes

Netia announced that starting April 15th, customers who purchase faster fiber optic options (up to 1 Gb/s and up to 2 Gb/s) in single-family homes will receive FTTR (Fiber to the Room) access kits with WiFi 7 at no additional cost. This solution allows the full fiber optic speed to be utilized in every room of the house. The kit consists of a router with a built-in ONT and a remote unit, creating a unified WiFi 7 network.

Netia is the first operator in Poland to offer such a solution. Piotr Rożalski, Head of B2C Offer Development and Combined Projects at Netia, emphasizes that FTTR is highly regarded in Asian countries and Western Europe, and he is confident that Polish customers will also appreciate this technology.

#### Orange Polska general meeting decides on dividend payment for 2024

The General Meeting of Orange Polska has decided on a dividend payment for 2024 amounting to PLN 0.53 per share, totaling PLN 695.5 million. The record date for the dividend is June 25, and the payment will be made on July 9, 2025. The company's net profit for 2024 was PLN 1.08 billion. Last year, the company paid a dividend of PLN 0.48 per share.

#### What about streaming royalties? "negotiations are ongoing"


The amendment to the Copyright Act introduced the obligation to pay royalties from the Internet. These regulations have been in effect since September 2024, but the process of collecting and distributing funds is complex and requires time. Creators can expect compensation from platforms that have signed agreements with collective management organizations, while negotiations with other services are ongoing.

Screenwriters, represented by the Polish Screenwriters Guild, actively fought for favorable provisions in the amendment. Platforms such as Polsat Box Go and Canal+ Online began paying royalties voluntarily, even before the law was enacted. Agreements with other platforms are under negotiation, and the full effects of the new regulations will be visible in the coming months. This process is complicated due to the global reach of platforms and various business models. Audiovisual creators are gradually receiving the compensation they deserve for the distribution of their works in the digital world.
