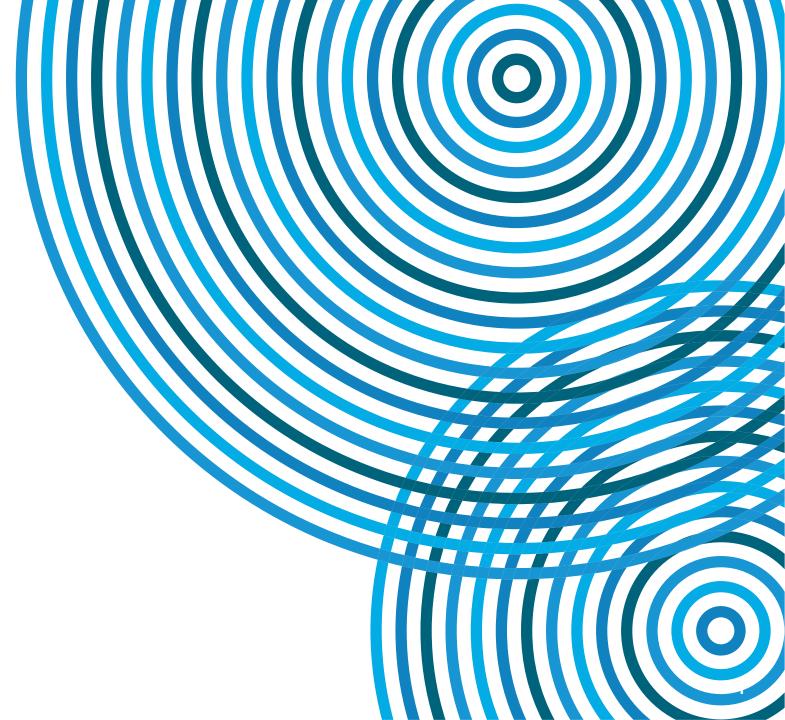

#### Expanded fiber coverage: PSO connects thousands of new households

In September 2025, the wholesale operator Polski Światłowód Otwarty (PŚO) expanded the reach of its fiber-optic network. A total of 53k households were added, including:

- 18k through newly built infrastructure across 68 towns,
- 35k through the upgrade of existing HFC infrastructure to the FTTH standard.

Currently, PŚO covers over 4.2 million households, of which 1.2 million are served by fiber-optic connections. The operator uses XGS-PON technology, enabling FTTH services with speeds of up to 8 Gbit/s.

PŚO operates exclusively in a wholesale model, making its network available to retail providers such as Play, T-Mobile, Netia, Plus, Orange, and local ISPs.

The strategic goal of PŚO is to reach over 6 million households across Poland.

#### Plus has the widest coverage – the numbers don't lie

Plus's fibre-optic internet offer is now available in over 11 million homes and apartments across Poland, both in large cities and smaller towns. The operator emphasises that this is the largest fixed internet coverage in the country, surpassing competitors such as T-Mobile (approx. 10 million), Orange (approx. 9 million), and Play (approx. 10 million, including the HFC network from UPC).

Around 23 million people can use Plus's home internet, which offers speeds of up to 1 Gb/s. This bandwidth allows for comfortable use of digital services such as 4K streaming, online gaming, video conferencing, and remote work.

Plus promotes bundling fibre-optic internet with other services – for example, mobile subscriptions, mobile internet, or television. As part of a promotion, two M services are available for PLN 80 per month, and the L package (fibre-optic up to 1 Gb/s, unlimited internet or TV with 142 channels) for an additional PLN 30. The offer is available to both new and existing customers, and availability can be checked at <a href="mailto:plus.pl/swiatlowod">plus.pl/swiatlowod</a>. The subscription price may increase by PLN 20 per month depending on infrastructure and building type.

#### Canal+ increases revenue. Poland leads the growth

The Canal+ Group recorded a revenue increase to €4.61 billion during the first nine months of 2025. A key driver of this growth was the Polish market, which stood out among other countries. In Poland, significant development occurred in the pay-TV segment, where the price of the main package rose following the launch of the new Canal+ Super Sport offer. Additionally, higher advertising revenues from Canal+ thematic channels – manager by Polsat Media – positively impacted the results.

In contrast to Poland, revenue declined in France, Canal+'s home market. This was due in part to the termination of the partnership with Disney+ and the loss of the Champions League sublicensing rights. Moreover, the shutdown of the free-to-air terrestrial channel C8 negatively affected advertising income.

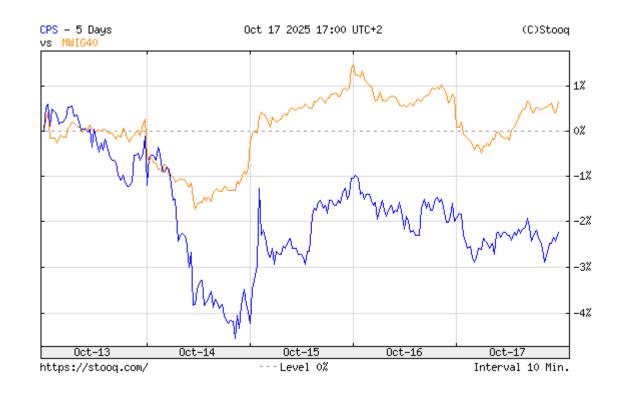
