

#### Paweł Galej joins the Management Board of Play

#### **Netia Shortens the Path to the Cloud. It's Cheaper and Faster**

Netia has established a direct connection to the Warsaw region of Google Cloud, becoming an official Google Cloud Interconnect partner. The connection was implemented through the Netia Cloud Tunnel service, using two independent physical routes to ensure redundancy and continuity. Direct access to Google Cloud's data center in Warsaw reduces data transfer time, which is crucial for applications requiring low latency, such as analytics systems, AI, and big data. Netia guarantees dedicated bandwidth between the client's infrastructure and cloud resources.

The partnership with Google Cloud Poland is part of a broader collaboration between Polsat Plus Group and Google, launched in October 2023. It includes projects related to digital transformation and artificial intelligence. As part of this cooperation, an agreement was also signed for the purchase of energy from a wind farm.

The Cloud Tunnel offer is mainly targeted at B2B customers, especially those developing solutions based on large data sets, machine learning, and AI.

#### **Charges in Prepaid Telephony – Polkomtel Facing UOKiK Allegations**

The President of UOKiK has initiated proceedings against Polkomtel (operator of the Plus network) regarding practices in prepaid offers. The authority accuses the company of charging a fee for maintaining a number (PLN 5 per month), which replaced the previous inactivity fee (PLN 3), and of unilaterally increasing service prices in ongoing prepaid agreements, including funds on accounts. It also pointed out incomplete information about additional charges on starter pack packaging in the "Plus Elastyczna na Kartę," "Prosto na Kartę," and "Giga Plus" tariffs.

Similar allegations concern other operators – UOKiK is conducting proceedings against Play (P4) and Orange.


