It is a struggle of all against all, because it no longer involves only fixed-line, cable and mobile operators. At the end of last year, Mobyland and CenterNet offered the wholesale mobile Internet service with speed up to 150 Mb/s (in LTE technology), and this quarter Cyfrowy Polsat will offer a retail service. Also Polkomtel will begin the tests of such internet service.		
Parkiet: More subscribers? According to analysts, the increase in the number of subscribers will continue in 2011. Dominik Libicki, President of Cyfrowy Polsat, estimates the penetration of pay-TV (offered by digital platforms and cable operators) market in Poland at about 70 percent. - In Poland, the potential for development still remains at a level of more than a million households - he says.	12.01	Dziennik Gazeta Prawna: Polkomtel, Plus network operator, will be sold The process of selling one of the largest Polish mobile operators has formally begun.
