	17.06	Rzeczpospolita: Plus mobile network will save on the debt 16 banks and PZU participated in the refinancing of debt of Plus network operator. According to Joanna Nieckarz, responsible for finance on the Management Board of Polkomtel, lower cost of debt servicing will enable the company to invest more in the development of mobile LTE Internet access services and in customers acquisition.
	18.06	Dziennik Gazeta Prawna: Play and T-Mobile want to catch up with Solorz-Zak Yesterday, Magdalena Gaj, President of the Office of Electronic Communications, issued reservations for 1800 MHz frequencies for Play and T-Mobile. Thanks to them, the operators can build LTE high-speed Internet networks. The first transmitters are due to run already this year, as the companies want to launch an offer competitive to Plus and Cyfrowy Polsat, the only providers currently offering LTE.
	19.06	Dziennik Gazeta Prawna: It actually works. Offensive of digital music services has been successful At least a million – this is the music industry's unofficial estimation of the number of users who have been attracted in the first, not even full, quarter of operations by the global music streaming services - Spotify, Deezer, WiMP – as well as Polish Muzo. Based on data of the Association of Audio-Video Producers, pay subscription could have been purchased by 200-220 thousand people.
	20.06	Rzeczpospolita: Not much of online television Except the pay-TV operators' offers, the most of the coded TV channels interesting for audience are still unavailable online in video streaming technology. The fact that the online video service Ipla, owned by Polsat, has started to offer 14 classic linear TV channels, does not change much on the Polish market. Among these channels, there is only one of a foreign broadcaster - Discovery.

Parkiet: Rising valuation of shares BDM brokerage analysts, in the report dated June 17, lowered recommendation for Cyfrowy Polsat to "hold" from "accumulate". At the same time, however, they raised the target price to PLN 20.82 (from PLN 18.7). On Thursday afternoon, the shares were traded at approximately PLN 19.5.	21.06	
Parkiet: Stars, that will shine with the results for the second quarter According to analysts, companies in the media sector, including TVN and Cyfrowy Polsat, are doing quite well. – They may show relatively good results. I expect a significant slow-down in the negative dynamics of advertising revenues compared to the large decline in the first quarter, which should reassure investors that there is a chance of returning to growth in the coming periods - said Dominik Niszcz, analyst at Raiffeisen brokerage.	22.06


