Cyfrowy Polsat added the OTT IP TV service to its smartDOM discount scheme. In addition the company offers the Evobox Stream STB, which enables access to the service, without charging the monthly rental fee for the set-top box.

smartDOM discount scheme offers customers discounts for each additional service they buy from among the services offered by Cyfrowy Polsat Group. The scheme includes a dozen or so diverse services, including TV access (DVB-T terrestrial TV, satellite TV, cable TV, and now also the IPTV service), telecommunication services (postpaid voice, mobile and home Internet access, Internet access over fiber-optic lines) as well as natural gas supply, electricity and insurance services.



A new promotion from Plus: "In the United Kingdom like at Home" by bg

From 1 January 2021 the customers of Polkomtel mobile operator (a Cyfrowy Polsat Group company) can continue using mobile services in the United Kingdom on existing terms, i.e. in line with "Roam like at home" principle.

Customers using the services in the UK (which has ceased to be a member of the European Union) will be paying the same charges as to date for using voice, SMS and MMS transmission as well for data transmission services which are covered by the bundles.

"In the United Kingdom like at home" promotion has been launched for all customers using Plus and Plush brands who use roaming services or international calls based on postpaid, mix and prepaid offers.

920 employees of Orange Polska to be laid off in 2021. Salary rises will be lower

Orange Polska has signed a final agreement with the trade unions providing for modifications in the schedule of

Orange Polska has signed a final agreement with the trade unions providing for modifications in the schedule of lay-offs and salary rises.

The total number of jobs to be axed in 2021 will be 920, which means a lower scale of lay-offs than originally assumed. The target level of reduction of job positions is 2.1 thousand. The anticipated employment reduction does not include the employees leaving at their own request.

In addition, the signed agreement provides for a 1% salary growth in 2020 (versus the earlier plan to increase the salaries by 3.5%), while in 2021 the salary growth will be 3.5% (just as originally agreed).

The Office of Electronic Communications (UKE) noted that the agreement concluded by and between the United Kingdom and the EU at the end of 2020 did not include roaming-related solutions.

This means that from January 2021 onwards the prices for using roaming services in the United Kingdom will no longer be based on the "Roam like at Home" EU principle and hence they may increase.

As was noted by UKE, even though the "Roam like at Home" principle has not been guaranteed on legal grounds, still EU operators may continue applying it at their own initiative.

"Customers should pay special attention to the terms of use of roaming services in the UK since these terms may differ depending on the provider used and a specific offer that a customer selected," stressed UKE.




